CURRICULUM VITAE

ATTILIO GUARNERI was born on 1st March 1946.

He was a student at the Collegio Ghislieri of Pavia where he graduated in law on 27th November 1968 with an honours degree (110/110 *cum laude*). His degree dissertation, discussed with Prof. Rodolfo Sacco was entitled "Contracts contrary to public policy".

On 16th May 1971 he became assistant lecturer to Prof. Piero Schlesinger where he taught Institutions of Private Law at the University of Pavia, faculty of law.

On 20th April 1972 he entered in the register of Barristers and Solicitors of Cremona.

On 1st January 1973 he was appointed vice-chairman of the First Degree Tax Commission of Cremona, office he held until November 28, 2012, when he resigned due to incompatibility pursuant to art. 1, paragraph 128, law 190/2012.

From 1st November 1974 to 31th October 1977 he taught Private law institutions at the political science faculty of the University of Trieste.

From 1st November 1977 to 31th October 1980 he taught Comparative Law at the University of Padova, faculty of Law.

From 1st November 1980 to 31th October 1999 he taught Comparative Law and Institutions of Private Law at the University of Parma, faculty of law.

From 1st November 1999 to 31th October 2016 he taught Comparative Law at the Bocconi University of Milan.

By decree of the Minister of University and Research on 13th August 2020 he was appointed Professor Emeritus.

He maintains, by contract, the teaching of Civil law at the Bocconi University in Milan in collaboration with prof. Inzitari.

He also teaches civil law at the specialization school for the legal professions set up by the University of Pavia and the Bocconi University of Milan.

He taught in the *Master in Real Estate* (MRE) at the SDA of Bocconi University.

From 1993-1995 he was a member of the Administration Council S.P.E.C. (the Public Environmental Company s.p.a.) in Cremona.

From September 1997 to April 2004 he was a member of the Board of the Banca Popolare di Cremona.

From 15th October 2013 to 20th April 2015 he was a member of the board of directors of RCS Mediagroup s.p.a.

From 12th July 2012 to 14th June 2018 he was a member of the board of statutory auditors of the s.p.a. Velca, with headquarters in Milan, via Borgogna, n. 3, a company of the Policlinico San Donato s.p.a. group He is a member of the Italian Association of Comparative Law.

He was vice-chairman of the Gruppo Italiano of Association Henri Capitant pour la diffusion de la culture juridique française in Paris.

He was a member of the executive Committee of the specialization school for the legal profession set up by the University of Pavia and the University of Milan from its foundation to 31th October 2016.

He was a member of the executive Committee of the revue "Antologia", publishing house CEDAM, Padova.

He is a member of the executive Committee of the revue "Responsabilità civile e previdenza", publishing house GIUFFRE', Milan.

He is a member of the scientific Committee of the revue "Nuova giurisprudenza civile commentata", publishers CEDAM, Padova.

He is by election associate member of the "Académie Internationale de droit compare", held in Utrecht on 22nd July 2006 at the XVII International Congress of Comparative Law.

On 10th September 2007, he received the didactics award A.A. 2006-2007 for best lecturer at the school of law (optional teaching) Bocconi University, Milan.
