Research fields: I am a public lawyer, with research interests spanning both administrative law and European Union law, with specific focus on three areas: the comparative law of administrative procedures, the general principles of law, and budgetary issues.

Academic position: I am a full professor since 2001, and Professor of Administrative Law at the Bocconi University (Milan) since September 2018.

Awards and Honors

In 2016 I have been awarded an advanced grant by the European Research Council for the research project on “*The Common Core of European Administrative Laws*”, for a period of five years.

In 2018, I have received the first prize in the *Spinelli Outreach Prize*, for the work concerning the codification of administrative procedures published by ReNEUAL.

Publications

I have published many books and articles in leading journals worldwide, in both English and French, including six monographs, the last of which are *Due Process of Law Beyond the State. Requirements of Administrative Procedure* (OUP, 2017). I have also edited twenty books, including the *Research Handbook of European Administrative Law* (co-authored with Carol Harlow and Paivi Leino; Hart, 2017), *Tort Liability of Public Authorities in European Law* (co-edited with Roberto Caranta; Oxford University Press, 2020) and *Administrative Justice Fin de siècle* (co-edited with Stefano Mannoni, Oxford University Press, 2021).
